Telangana: ED conducts raids in sheep 'scam' case

The Enforcement Directorate (ED) conducted searches at multiple locations in Hyderabad on Wednesday as part of a money-laundering probe into a sheep rearing and distribution "scam" worth crores of rupees that allegedly took place in Telangana during the previous BRS regime, official sources said.

At least eight locations in the city related to beneficiaries and alleged middlemen involved in the scam, including the premises of G Kalyan, Officer on Special Duty (OSD)

to former BRS minister (animal husbandry and fisheries) Talasani Srinivasa Yadav, were covered as part of operation conducted under Prevention of Money Laundering Act (PMLA), they said.

The probe stems from a Telangana Police Anti-Corruption Bureau (ACB) FIR of December 2023. The ACB arrested four government officers in February 2024.

The Sheep Rearing Development Scheme (SRDS) was launched by the Bharat Rashtra Samithi (BRS) government in the southern state in April 2017 to provide a sustainable livelihood to shepherd families and boost their

income. The sources said that though the "proceeds of crime" amounted to only Rs 2.1 crore, a CAG report has pegged the loss to the state government at crores of rupees. The report for period ending in March 2021 found several "irregularities" in the flagship SRDS like non-maintenance of beneficiary-wise details, improper record pertaining to transportation invoices and payments, payments against invoices containing registration numbers that are either fake or of passenger vehicles or non-transport vehicles, duplicate tags allotted to sheep units etc.

No jurisdiction to hear bail plea of Kerala nuns: MP court

A sessions court in Chhattisgarh's Durg district on Wednesday said it does not have the jurisdiction to hear the bail application of the three persons including two Catholic nuns from Kerala arrested for alleged human trafficking and illegal conversion.

In their application, the accused claimed that the three tribal girls who were to accompany them to Agra were already following Christianity, and hence there was no question of converting them.

Additional Sessions Judge Anish Dubey, while disposing of the bail pleas, said they will have to move a special court for relief.

"The District and Sessions Court, Durg has not been given the jurisdiction to hear the case under section 11 of the National Investigation Agency Act, 2008, by the State or Central Government with the approval of the Hon'ble Chhattisgarh High Court....this court does not have the jurisdiction to hear the crime shown under the said Act," the court order stated.

Priyanka slams BJP

Congress leader Priyanka Gandhi Vadra on Wednesday slammed the BJP over alleged atrocities on minorities as she protested in the Parliament House complex along with some other opposition MPs from Kerala against the arrest of two Catholic nuns in Chhattisgarh.

Before the start of Lok Sabha proceedings, Priyanka Gandhi, Congress general secretary K C Venugopal, RSP MP N K Premchandran and some other Congress MPs from Kerala stage a protest near Makar Dwar of Parliament, demanding the release of the nuns.

Sidda blames Centre for urea shortage

Karnataka Chief Minister Siddaramaiah on Wednesday accused the Centre of "reducing the state's urea allocation", leading to a shortage at a time when sowing activity is in full swing following good rainfall.

He said the state has received favourable rains this season and that sowing activity has picked up significantly. However, he claimed the reduced supply of urea has led to a shortage, affecting farmers during this crucial period. During a review meet, the chief minister's office shared these observations.

Against the requirement of 11.17 lakh metric tonnes (MT) between April and July, only 5.17 lakh MT has been supplied, he said.

"The allocation was curtailed despite an increase in hybrid jowar sowing by two lakh hectares this year. Despite the Centre's non-cooperation, our farmers should not face any hardship," he claimed.
